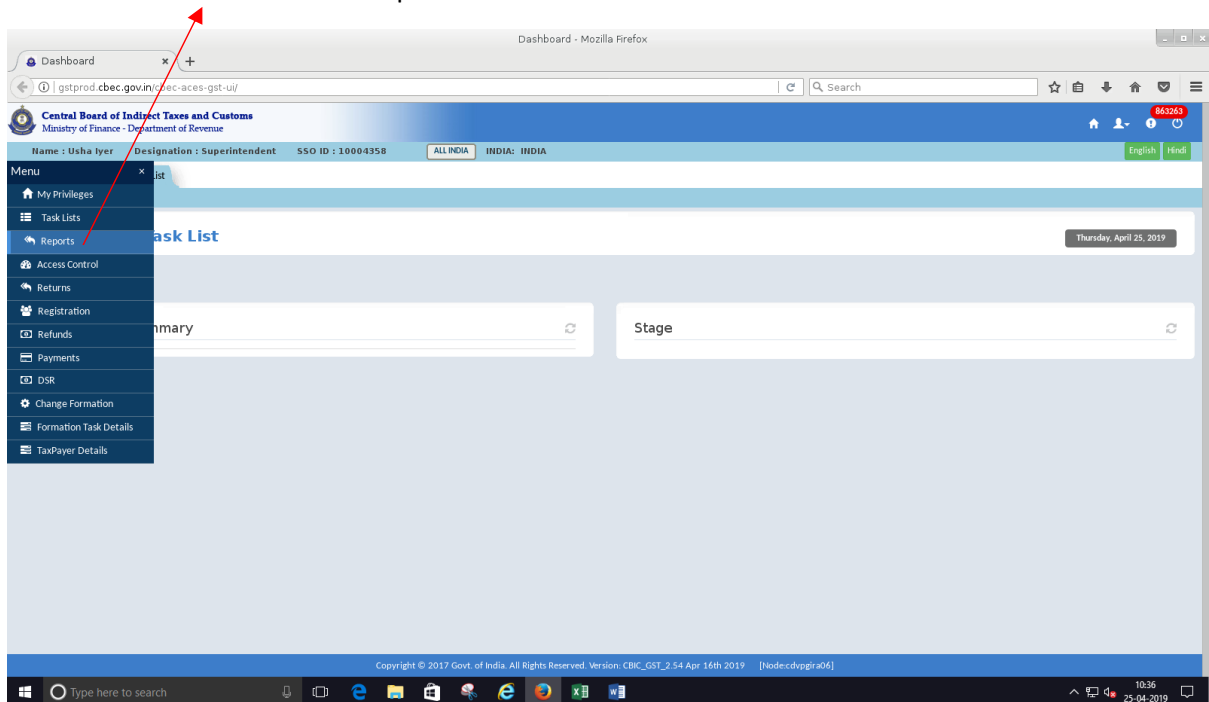


## USER MANUAL ON REGISTRATION HISTORY OF AMENDMENTS BY TAXPAYERS

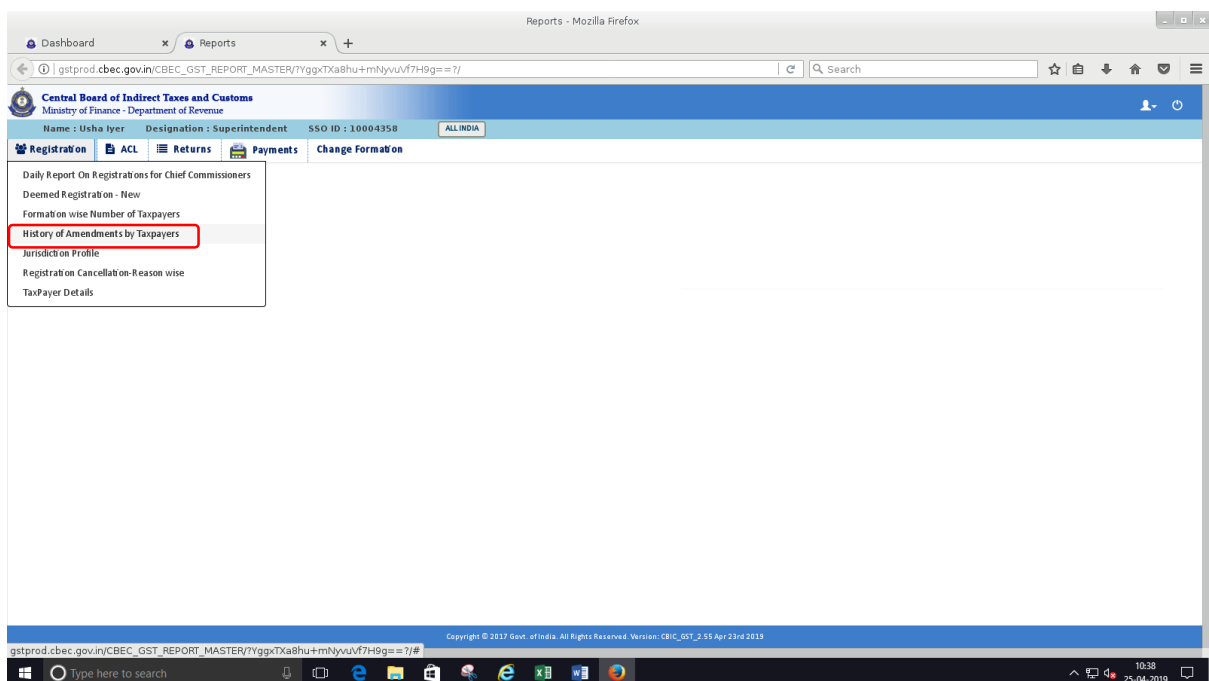
Under Registration Module a new report viz., History of Amendments by taxpayer has been developed. This report gives the details of registration amendments, which are done by Taxpayer, for a selected jurisdiction- selected period.

Navigational path to the said report along with screen shots is given as below.  
After successful login to the citrix application in AIO, choose the Menu.

3. Search parameters are available as displayed in the screen below.

'Formation' can be selected to which the officer is mapped. 'Type' will have LOV 's for following Registration Types, (All, Normal, Casual, TDS,TCS, UIN, OIDAR). (Presently Amendment is deployed only for Normal Taxpayers, hence report will capture for Normal Registrations).

Selection of 'From and To period', 'Supervision by Centre/State', 'Migrated/New Taxpayer' are also available.
