METHOD-1: Using Income Tax (CBDT) web site><https://www.incometaxindiaefiling.gov.in>

1. Go to Income Tax e-filing site> Home page >

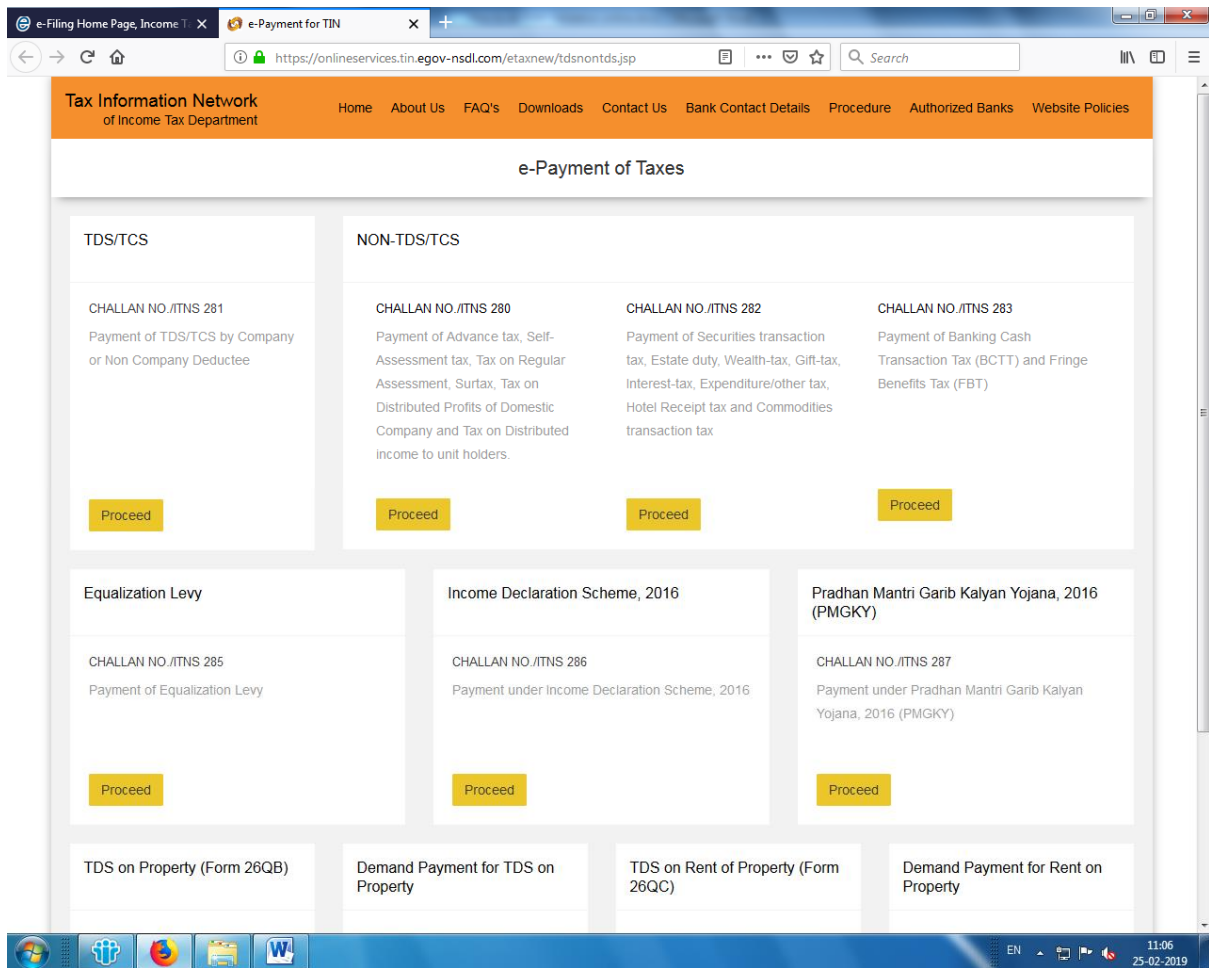
