Subject: PMO reference forwarding therewith a representation received from Smt. Sukanya Das, D/o Late Shri Golap Ch. Das, regarding appointment on Compassionate ground - reg.

With reference to the above cited subject, brief facts of your case is stated below.

It may be mentioned that Smt. Charu Prova Das W/o (Lt) Golap Ch. Das, Superintendent, submitted application on 13/02/2003, requesting for Compassionate Appointment for herself as her Educational Qualification is HSLC passed. However, on 19/04/2005, she changed her application in her daughter's name i.e, Smt. Sukanya Das, who appeared HSSLC and then her mother intimated that on 27.11.2005, Smti Sukanya Das passed HSSLC. On 18/02/2014, Smti Sukanya Das submitted the document that she is already graduate in 2008. But, on 03/05/2017, she submits another application requesting for the post of Computer Assistant or any other clerical job.

As per the Screening Committee held on 09th September, 2010, her case was examined but as per Board's letter F.NO.A 12012/69/2007-Ad.IIIB dated 19.01.2009, the case was closed as the limitation of 3 (three) years period is over. Intimation forwarded to the applicant by post on 13.10.2010.

Again, the Screening Committee Meeting held on 08th July, 2013 reviewed withdrawal of 3(three) year's period vide DOPT's O.M. F.No. 14014/3/2011-Estt (D) dated 26/7/2012. Therefore, all pending applications as on date were scrutinized, since these applications relates to the past period, the information provided by the applicants regarding Educational Qualification and others were required to be updated for consideration by the Committee.

Again, the Screening Committee held on 8th July, 2013 reviewed withdrawal of 3 (three) years period vide DOPT's OM F.No 14014/3/2011- Estt(D) dated 26/7/2012. Therefore, all pending applications as on date were scrutinized, Since these applications relates to the past period, the information provided by the applicants regarding Educational Qualification and others were required to be updated for consideration by the Committee.

Again as per DOPT's O.M. F.No. 14014/3/2011 – Estt (D) dated 26/7/2012 the 3 years limitation has been reviewed and all closed cases have been re – opened . On 8/7/13 the Screening Committee met to scrutinize all cases and decided that after a lapse of many years, updated information such as educational qualification family pension drawn etc. will be required for consideration afresh for compassionate appointment. On 10.07.2013 intimation was also forwarded to all applicant. Accordingly, all applicants had been directed to furnish updated information to this office. Most of the information received from the applicants were sometimes in- complete and in-correct which require re- submission of correct information. Thus, a lot of time was taken for their updation.

In 2014-15, with the implementation of Cadre Restructuring, 5(five) posts arose in the grade of Tax Assistant to be filled up on Compassionate ground. The Screening Committee frequently met to scrutinize the documents submitted by the applicants. On completion of all investigation, the Screening Committee finally met on 09/12/16 and examined all the applications along with that of Smti Sukanya Das, their financial verification and eligibility criteria for compassionate appointment to fill up the 5 posts of Tax Assistant.

On going through all the applications and keeping in view all the objectives and instruction on modalities of compassionate appointment, the Committee considered that in view of limited number of vacancies only those applicants with acute financial crises who deserved immediate financial assistance would be recommended for appointment on compassionate ground.

Thus, your application was duly considered in the Screening Committee held on 09/12/2016 but appointment could not be offered due to lack of vacancies.

However, in respect of Computer Assistant, there is no such post to be filled up on Compassionate ground.

This issues with the approval of the Commissioner, Goods & Service Tax, Shillong Commissionerate.
